Fish/Water Quality (Christian, Phil) - Christian said they had a good turn out for the Fish Tournament. Phil - Continuing work with LimnoTech in Developing quality plans for the Watershed Management plan Attended VIRTUAL Annual Great Lakes Conference. Couple of interesting takeaways:

- Multiple comments that there are significant gaps in Septic System understanding, AND there is more "leakage" being discovered than previously expected.
- Covid 19 studies of waste water systems indicates levels found in waste water could be correlated to outbreaks 2 weeks later – and Covid in waste product is essentially dead – probably cannot survive the human digestive tract.

Did a lake tour today for Pamela Dugan from Eutrophix. Request for Water Quality Meter. Asked for updated quote with Calibration fluids included. Also questioned other lakes about interest in sharing cost. Sand Lake and Wamplers Lake not interested. Lake LeAnn did not reply. Checking possibility of rental units too. Phil motioned to approve of the purchase of water quality meter \$7500 or an annual rental of half of that, Christian second, all in favor.

**Building (Don Deneweth)** - Don said he had 2 approvals, a porch addition in kingsley and a home in kingsley, Don asked Tom from Irish Mist if the home was approved by them and it was.
